LOCAL VENDOR ALLOWANCE QUALIFICATIONS

Pursuant to the City of Dalton Purchasing Policy, a local vendor allowance permits qualifying local vendors who bid within 4% of the low bid an opportunity to match the low bidder within 24 hours of notification to the City Finance Department or department issuing bid when bidding for supplies, equipment, materials, and personal services that are not part of a public works project. If more than one local vendor meets the qualifications, the lowest bidder will be given the first opportunity to agree to match the low bid. If they refuse, the next lowest bidder will get the opportunity and so on until all local vendors within the 4% range have been given an opportunity.

In order to qualify for this allowance, a vendor must meet all of the following criteria:

- 1. The local business shall have established a physical place of business within Whitfield County. A Post Office Box does not meet this requirement.
- 2. The local business must have at least two (2) employees who have worked in Whitfield County for at least six (6) months prior to submitting the bid.
- 3. The local business must be current on property tax and city occupation tax (if located within City limits).

Bidders claiming local vendor allowance for any Bid, Price Quote, or RFP must submit an Affidavit of Eligibility (see next page) with their bid or quote response.
