- Any building that is under the jurisdiction of the Georgia State Fire Marshal's Office must still be submitted for review and approval to the City of Dalton Fire Marshal's Office if the building is within the city limits.
- All plans must follow the normal submittal process for The City of Dalton Fire Marshal's Office.
- The City of Dalton Fire Marshal's Office will charge a review fee for all reviews as stated in the fee schedule on this website.
