#### **Department Overview**

The City of Dalton Fire Department is an ISO Class 2 emergency service provider consisting of 97 full-time employees. 89 personnel are assigned to the suppression division as firefighters. Additional personnel are assigned to the training division, fire prevention division, and as administrative staff. The department has 39 Emergency Medical Technicians, 4 Paramedics, 54 Emergency Medical Responders, 27 certified Georgia Smoke Divers, and 12 CPR instructors. Training hours accrued during 2017 totaled 35,290.

The department has Special Operations Teams trained in technical rescue and hazardous materials response. These teams are adept at mitigating incidents such as trench rescue, structural collapse, vehicle and machinery entrapment, surface water rescue, high and low angle rope operations, confined space rescue and hazardous materials releases.

Emergency response capabilities are achieved through the use of eight pumping apparatus, one 100-foot tower ladder, one 75-foot straight ladder, one heavy rescue apparatus, one incident command vehicle, and one mobile air & light unit, all of which are fully equipped to comply with NFPA and ISO requirements. Thermal imaging cameras, which allow for enhanced visibility in hostile environments, are carried in all 5 districts so that all the city's inhabitants may benefit from this technology.

The department has 5 stations located to provide rapid response to any part of the city's 22 square miles. Station 2, located on Abutment Road, also serves as a training facility with a water drafting pit, four story drill tower, and a three story, 1,664 sq. ft. burn building designed for the burning of Class A materials in all areas of the structure. This facility is utilized to train new recruits and maintain proficiency among incumbent personnel. All fire stations are equipped with stand-by generators to provide electrical power in the event of an outage. Stations are also equipped with a communications duplication system to ensure that the vital link between fire dispatchers and units operating in the field remains intact should the 911 center be disabled.

The City of Dalton has a total of 1,249 municipal fire hydrants. These hydrants are inspected a minimum of twice annually by suppression personnel. The department works closely with Dalton Utilities in an effort to ensure that hydrants will function properly if needed. In addition, there are over 500 private hydrants located in various parts of our jurisdiction serving a variety of private properties.

The fire prevention division works closely with the building inspector's office and Dalton Utilities in an effort to reduce the loss of life and property by requiring that all construction meets current fire codes.

### **Accomplishments**

- 1. The department placed a total of 88 new mobile and portable radios in service on the SPLOST funded digital emergency radio communications system.
- 2. Several major building maintenance projects were completed during 2017. The entire interior of Station 4, along with all common areas on the second floor of Station 1, received a fresh coat of paint. Additionally, two new apparatus bay doors were installed at Station 2.
- 3. Significant equipment upgrades were made in the workout areas at all stations. Purchases included dumbbells, free weights, and multi-functional exercise equipment.
- 4. 21 sets of structural protective clothing were purchased to replace damaged or aging turnout gear.
- 5. The Training Division conducted spring and fall recruit training programs that graduated a total of 8 new firefighters.
- 6. All battery powered carpentry toolkits on Squad 1 were replaced to improve serviceability and effectiveness.
- 7. A Masimo RAD-57 pulse CO-oximeter was purchased to monitor personnel for carbon monoxide concentrations in the bloodstream
- 8. At total of 4 new Bullard thermal imaging cameras were placed in service to replace outdated equipment or expand capabilities.
- 9. The Training Division conducted a 40-hour fire officer training program to better prepare senior firefighters and officer candidates for the duties of a company officer.
- 10. The department purchased 8 DuPont Level A hazardous materials entry suits to replace expired chemical protective clothing
- 11. The department participated in a joint training exercise with Dalton Police Department on response to active shooter incidents. The drill stressed the importance of multi-agency coordination and unified command.
- 12. The Training Division, in conjunction with Dalton Utilities Gas Regulatory Compliance Division, conducted scenario-based training on natural gas emergency response to better prepare suppression personnel for joint operations at these incidents.
- 13. The department updated all Standard Operating Guidelines (SOGs) and Standard Operating Procedures (SOPs) as well as all job descriptions during 2017.

# 2017 Statistical Data

#### Number of incidents

• The City of Dalton Fire Department responded to a total of 3,719 calls during 2017, an increase from the 3,590 calls answered during 2016.

#### **Response time**

- Average response time for emergency calls was 3 minutes 27 seconds.
- Overall response time for all calls (emergency & non-emergency) was 3 minutes 36 seconds compared to 3 minutes 35 seconds in 2016.
- For multi-company responses, the average arrival time for the second due unit was 6 minutes 54 seconds.

#### Dollar value saved & loss analysis

- Total estimated property value exposed was \$43,201,143
- Total estimated property value lost was \$2,909,668
- Total estimated property value saved was \$40,291,475
- Total percent lost was 6.74%
- Total percent saved was 93.26%

#### Fires

- There were 165 actual fires reported in 2017 compared to 166 reported in 2016
  - There were 49 residential fires in 2017 compared to 41 in 2016
  - There were 17 commercial fires in 2017 compared to 18 in 2016
  - Total structure fires were 66 compared to 59 in both 2016 and 2015
  - There were 19 vehicle fires in 2017 compared to 25 in 2016
  - There were 18 brush/grass/wild land fires in 2017 compared to 37 in 2016
  - There were 29 rubbish/dumpster fires in 2017 compared to 31 in 2016
  - The Other category accounted for 10 fires in 2017 compared to 14 in 2016
- Fires accounted for 4.43% of the total incidents responded to by the department in 2017 compared to 5.51% in 2016

#### **Property damage** (from actual fires)

- Estimated property damage from fire was \$2,819,669 in 2017 compared to \$2,087,925 in 2016
- Damage from residential fires was estimated at \$1,525,175 in 2017 compared to \$1,938,275 in 2016
- Damage from commercial fires was estimated at \$883,142 in 2017 compared to \$23,150 in 2016
- Total property damage from structure fires in 2017 totaled \$2,408,317 compared to \$1,961,425 in 2016
- Vehicle fires resulted in \$58,900 in losses compared to \$120,550 in 2016
- The all other fires category accounted for no losses in 2017 compared to \$5,950 in 2016

#### **Civilian fire deaths**

- There have been no civilian fire deaths in the City of Dalton since 2013
- There were 3 civilian fire deaths in the City of Dalton during 2013
- There were no civilian fire deaths in 2010, 2011, or 2012 and 2 each in 2009 and 2008

#### **Civilian fire injuries**

- There were four civilian injuries in 2017 compared to one in 2016 and three in 2015
- There was one civilian injury in 2014 and two in 2012 and 2013
- There were six in 2011, one in 2010, eight in 2009, and five in 2008

#### **Firefighter injuries**

- There was 1 firefighter injury in 2017 compared to 6 in 2016
- There were two firefighter injuries in 2015, 2014, and 2013 compared to three in 2012 and nine in 2011

#### **Rescue/Medical responses**

- There were 2,469 calls for rescue/emergency medical assistance compared to 2,375 in 2016
- Rescue/Medical incidents accounted for 66.38% of incidents versus 66.15% in 2016

#### False alarm responses

- There were 442 false alarms in 2017 compared to 394 in 2016
- There were 15 malicious/mischievous false calls in 2017, 2016, and 2015
- There were 171 system malfunctions in 2017 compared to 148 in 2016
- There were 246 unintentional false alarms in 2017 compared to 235 in 2016
- There was 1 other false alarm in 2017 compared to 2 in 2016
- The false alarm category accounted for 11.88% of all incidents

#### **Intentionally set fires**


- No structure fires were listed as intentionally set in 2017 or 2016
- No vehicle fires have been listed as intentionally set since 2012

#### Other statistics for 2017

- 82.29% of all calls occurred between 8:00am and 11:00pm
- The busiest day for calls was Tuesday with 15.16% (564 calls)
- The second busiest day for calls was Thursday with 15.05% (560 calls)
- Wednesday was the slowest day for incidents with 13.17% or 490 calls for service
- December was the busiest month with 357 calls for service
- District 1 accounted for 1,347 calls (36.21%) and accounted for \$374,630 in estimated losses (12.88% of total loss)
- District 2 accounted for 754 calls for service (20.27%) and accounted for \$814,602 in estimated dollar loss (28% of total loss)
- District 3 accounted for 745 calls for service (20.03%) and accounted for \$1,511,916 in estimated dollar loss (51.96% of total loss)

- District 4 accounted for 379 calls for service (10.19%) and accounted for \$42,120 in estimated dollar loss (1.45% of total loss)
- District 5 accounted for 368 calls for service (9.89%) and accounted for \$11,700 in estimated dollar loss (0.4% of total loss)
- Out of district calls accounted for 5.32% or 126 calls for service

## **Fire Prevention Division**

#### **Restaurants/Bars/Alcohol Inspections – 238**

These inspections include all food establishments with and without alcohol service. Numerous locations required multiple visits to obtain code compliance. When required, approval letters were issued to the City Clerk's Office enabling alcohol license to be issued.

#### Address Issues – 31

Dalton Fire Department handles all addressing issues within its jurisdiction. Upon request, letters confirming address changes were issued to home owners and/or mortgage companies for the purpose of verifying correct address. The county-wide readdressing project is in its fifth year with issues still arising from the initial changes. Some locations were given new street names and numerical identification, while others were only given new numerics. Dalton Fire Department continues to work with Geo-Comm when assigning new addresses.

#### **Code Compliance Inspections – 768**

These inspections pertain to all non-food service establishments (e.g., manufacturing, assembly, educational, and mercantile occupancies). Each location received an inspection based on the specific building use. Issues that arose included, but were not limited to, sprinkler service, alarm service, and general building maintenance.

#### Plans Reviewed - 43

Upon submittal of construction documents, each plan was reviewed for compliance with state and local codes. Areas reviewed consisted of proper sprinkler design and installation, means of egress, fire extinguisher placement, and fire alarm systems. Each occupancy type has its own unique requirements. Plan review can take as little as a couple of hours to a couple of days depending on the detail and complexity of the building and the operation contained in the structure.

#### Fire Safety Education Programs – 147

These events include public events (e.g., fairs, church functions, career days in public and private schools, Safe Kids seatbelt checks, and station tours). During these events, children were given fire safety education materials while adults were presented with more detailed literature. These events reached 8,602 adults and 15,881 children for a total of 24,483 citizens. Total staff hours for these events were 1,343.

#### Safe Kids Car Seat Events - 56

These events include public events at central locations (shopping centers, community centers, schools, etc.). During these events, child passenger safety technicians teach families how to transport children correctly. Dalton Fire Department is also an inspection station where citizens can come and request a car seat inspection by a child passenger safety technician. Citizens can receive a new seat through Safe Kids with a donation being suggested but not required. These events reached 102 adults and 89 children for a total of 191 citizens. Total staff hours for these events were 53.
