Department Overview

The City of Dalton Fire Department is an ISO Class 2 emergency service provider consisting of 97 full-time employees. 87 personnel are assigned to the suppression division as firefighters. Additional personnel are assigned to the training division, fire prevention division, and as administrative staff. The department has 42 Emergency Medical Technicians, 4 Paramedics, 50 Emergency Medical Responders, 28 certified Georgia Smoke Divers, and 12 CPR instructors. Training hours accrued during 2019 totaled 30,898.

The department has Special Operations Teams trained in technical rescue and hazardous materials response. These teams are adept at mitigating incidents such as trench rescue, structural collapse, vehicle and machinery entrapment, surface water rescue, high and low angle rope operations, confined space rescue and hazardous materials releases.

Emergency response capabilities are achieved through the use of seven pumping apparatus, one 100-foot tower ladder, one 75-foot straight ladder, one heavy rescue apparatus, one incident command vehicle, and one mobile air & light unit, all of which are fully equipped to comply with NFPA and ISO requirements. Thermal imaging cameras, which allow for enhanced visibility in hostile environments, are carried in all 5 districts so that all the city's inhabitants may benefit from this technology.

The department has 5 stations located to provide rapid response to any part of the city's 22 square miles. Station 2, located on Abutment Road, also serves as a training facility with a water drafting pit, four story drill tower, and a three story, 1,664 sq. ft. burn building designed for the burning of Class A materials in all areas of the structure. This facility is utilized to train new recruits and maintain proficiency among incumbent personnel. All fire stations are equipped with stand-by generators to provide electrical power in the event of an outage. Stations are also equipped with a communications duplication system to ensure that the vital link between fire dispatchers and units operating in the field remains intact should the 911 center be disabled.

The City of Dalton has a total of 1,252 municipal fire hydrants. These hydrants are inspected a minimum of twice annually by suppression personnel. The department works closely with Dalton Utilities in an effort to ensure that hydrants will function properly if needed. In addition, there are over 500 private hydrants located in various parts of our jurisdiction serving a variety of private properties.

The fire prevention division works closely with the building inspector's office and Dalton Utilities in an effort to reduce the loss of life and property by requiring that all construction meets current fire codes.

<u>Incident #</u> 19-3579 <u>Location:</u> 1210 Ludie St.

On Sunday, December 1, 2019 at 1457hrs, Dalton Fire Department Engine 2 was dispatched to an unconscious male patient at 1210 Ludie Street. Upon arrival, Engine 2 discovered CPR in progress on an unresponsive male patient. Engine 2 promptly reassessed the patient, applied an AED, and resumed CPR. After one shock was delivered by the AED, the patient regained a pulse, was responsive to pain, and began breathing on his own. The swift and skillful actions of Engine 2 ultimately resulted in the timely provision of life-saving care and contributed to a successful patient outcome. These actions reflect great credit upon the individuals involved, their assigned company, and the City of Dalton Fire Department.

Accomplishments

- 1. Instituted a schedule for review and revision of all standard operating guidelines and procedures
- 2. Implemented a three year strategic plan 2019-2021
- 3. Filled all applicable ranks through promotions
- 4. Conducted a fall recruit class that graduated 4 new firefighters
- 5. Added one additional inspector to the Fire Prevention Division
- 6. Replaced Automatic External Defibrillators (AEDs) on all front line fire apparatus
- 7. Lobbied for and obtained a city resolution granting oversight of facilities previously inspected by the state fire marshal's office
- 8. Completed projects focused on cancer prevention initiatives for firefighters
 - a. Constructed walls that separate turnout gear lockers from living quarters and apparatus bay areas at Stations 3 and 4
 - b. Installed a turnout gear extractor at Station 3
- 9. Completed several building and grounds projects at multiple locations
 - a. Replaced apparatus bay heaters at Station 4 with radiant heaters to improve energy efficiency
 - b. Replaced insulation on HVAC registers at Station 5 to correct a condensation problem
 - c. A stacked stone retaining wall with additional sidewalks and curbing were installed in the parking area at Station 1 by Dalton Public Works Department
 - d. An aluminum awning was installed outside the foyer area of Station 1
 - e. Constructed wall lockers in the Battalion Chief's quarters at Station 1 to provide additional storage

- 10. Delivered a 120-hour Rope Rescue Technician course to newly appointed members of the department's Technical Rescue Team
- 11. Presented one Citizen Heroism Award, three Citizen Lifesaving Awards, and one Citizen Recognition Award to members of our community to publicly acknowledge their service to others
- 12. Delivered a 40-hour Confined Space Rescue Technician course to newly appointed members of the department's Technical Rescue Team
- 13. Participated in numerous Dalton-Whitfield Special Olympics events throughout the year
- 14. Hosted three 16-hour Modular Emergency Response Radiological Transport Training (MERRTT) courses and an 8-hour MERRTT Technician level course sponsored by GEMA and delivered by the U. S. Department of Energy' Transportation Emergency Preparedness Program
- 15. Hosted Georgia Smoke Diver Class 57 in the spring and Class 58 in the fall
- 16. Implemented a fee schedule for review of: new commercial buildings and existing commercial additions, site plans, commercial plans, sprinkler plans, fire alarm plans, commercial hood system plans, and special inspections
- 17. Participated in the City of Dalton's Citizens Government Academy
- 18. The Fire Prevention Division had successful project oversight of: Anna Shaw Children's Institute, Peeples Cancer Institute, Food City, Waffle House, Ulta Beauty, Rak Outfitters, AT&T Store, Pet Smart, Ross Dress for Less, Kay Jewelers, Dalton Mall, KFC, Transformers Transmission, Dalton Storage, Hamilton Residence Renovation, Hamilton 2nd Floor Renovation, Shaw 61 Renovation, Just Jump, Department of Defense Recruitment Center, Roses, and Dalton Mini-Warehouses

2019 Statistical Data

Number of incidents

• The City of Dalton Fire Department responded to a total of 3,906 calls during 2019, an increase from the 3,867 calls answered during 2018.

Response time

- Average response time for emergency calls was 3 minutes 22 seconds.
- Overall response time for all calls (emergency & non-emergency) was 3 minutes 33 seconds.
- For multi-company responses, the average arrival time for the second-due unit was 6 minutes 50 seconds.

Dollar value saved & loss analysis

- Total estimated property value exposed was \$39,086,923
- Total estimated property value lost was \$2,180,365
- Total estimated property value saved was \$36,906,558
- Total percent lost was 5.58%
- Total percent saved was 94.42%

Fires

- There were 118 actual fires reported in 2019 compared to 121 reported in 2018
 - o There were 41 residential fires in 2019 compared to 27 in 2018
 - o There were 7 commercial fires in 2019 compared to 11 in 2018
 - o Total structure fires were 48 compared to 38 in 2018
 - o There were 20 vehicle fires in 2019 compared to 20 in 2018
 - o There were 19 brush/grass/wild land fires in 2019 compared to 27 in 2018
 - o There were 22 rubbish/dumpster fires in 2019 compared to 28 in 2018
 - o The Other category accounted for 9 fires in 2019 compared to 7 in 2018
- Fires accounted for 3.48% of the total incidents responded to by the department in 2019 compared to 3.12% in 2018

Property damage (from actual fires)

- Estimated property damage from fire was \$1,699,673 in 2019 compared to \$317,400 in 2018 and \$2,819,669 in 2017
- Damage from residential fires was estimated at \$1,078,450 in 2019 compared to \$241,800 in 2018 and \$1,525,175 in 2017
- Damage from commercial fires was estimated at \$554,500 in 2019 compared to \$15,270 in 2018 and \$883,142 in 2017
- Total property damage from structure fires in 2019 totaled \$1,632,950 compared to \$257,070 in 2018 and \$2,408,317 in 2017
- Vehicle fires resulted in \$65,723 in losses compared to \$60,330 in 2018
- The all other fires category accounted for \$1,000 in 2019 and no losses in 2018 or 2017

Civilian fire deaths

- There have been no civilian fire deaths in the City of Dalton since 2013
- There were 3 civilian fire deaths in the City of Dalton during 2013
- There were no civilian fire deaths in 2010, 2011, or 2012 and 2 each in 2009 and 2008

Civilian fire injuries

- There was one civilian injury in 2019, one in 2018, four in 2017, and one in 2016
- There were 3 civilian injuries in 2015, one in 2014, and two in 2012 and 2013
- There were six in 2011, one in 2010, eight in 2009, and five in 2008

Firefighter injuries

- There were four firefighter injuries in 2019, none in 2018, one in 2017, and six in 2016
- There were two firefighter injuries in 2015, 2014, and 2013 compared to three in 2012 and nine in 2011

Rescue/Medical responses

- There were 2,655 calls for rescue/emergency medical assistance compared to 2,602 in 2018
- Rescue/Medical incidents accounted for 67.97% of incidents versus 67.28% in 2018

False alarm responses

- There were 354 false alarms in 2019 compared to 427 in 2018
- There were 13 malicious/mischievous false calls compared to 17 in 2018
- There were 101 system malfunctions in 2019 compared to 142 in 2018
- There were 230 unintentional false alarms in 2019 compared to 262 in 2018
- The false alarm category accounted for 9.06% of all incidents

Intentionally set fires


- There were no structure fires listed as intentionally set in 2019 compared to one in 2018
- No vehicle fires have been listed as intentionally set since 2012

Other statistics for 2019

- 81.14% of all calls occurred between 8:00am and 11:00pm
- The busiest day for calls was Friday with 15.51% (606 calls)
- The second busiest day for calls was Tuesday with 14.72% (575 calls)
- Sunday was the slowest day for incidents with 13.41% or 524 calls for service
- June was the busiest month with 359 calls for service
- District 1 accounted for 1,507 calls (38.58%) and accounted for \$414,933 in estimated losses (19.03% of total loss)
- District 2 accounted for 804 calls for service (20.58%) and accounted for \$916,730 in estimated dollar loss (42.04% of total loss)
- District 3 accounted for 700 calls for service (17.92%) and accounted for \$193,600 in estimated dollar loss (8.88% of total loss)
- District 4 accounted for 424 calls for service (10.85%) and accounted for \$45,700 in estimated dollar loss (2.10% of total loss)

- District 5 accounted for 348 calls for service (8.90%) and accounted for \$609,402 in estimated dollar loss (27.95% of total loss)
- Out of district calls accounted for 3.14% or 123 calls for service
